- **Medical Officer of Health and Chief Executive Officer Reports**
 - i. MOH Report May 2021

A COVID activity update was provided by J. Loo, explaining that Algoma continues to see cases across the district which is expected to continue due to travel. A gradual decline in cases in the past week is a positive development. J. Loo shared that at the time of this meeting, the eligible adults over 18 years of age in Algoma, 54.5 percent, have received at least one dose of the immunization, representing 45.4 percent of the entire population in Algoma. Earlier in May, there was a reallocation of doses to hot spots in the province as the modelling showed it would impact hospitalizations, deaths prevented and possibly a 4th wave. At this time, allocations to Algoma have increased, and we will see the percentages of the immunized climb. The province's three-step plan for reopening has been presented, and we are currently in pre-step 1. There is no update on schools reopening at this time.

L.Zeppa provided an update on the Oral Health program, highlighting the Ontario Seniors Dental Health program launched in November of 2019. The program was maintained and delivered throughout COVID to a vulnerable population of low-income seniors in Algoma.

J. Loo addressed concerns about the booking process for vaccination. Staff have been increased on the phone lines that have also been expanded significantly. There had been an issue with the service provider that contributed to long wait times for booking the first dose vaccine appointments. Booking the second dose will be a different booking method than the first.

An update on staff recruitment was provided by A. Tomie, explaining the strategy for hiring to provide for program delivery while maintaining clinics and phone lines. The process for recruitment via a virtual platform has proven to be effective.
