a. Medical Officer of Health and Chief Executive Officer Reports

i. MOH Report - November 24, 2021

J. Loo provided an update on the key statement issued to all Algoma communities as a result of the surge in cases to take three key actions; get vaccinated, stay home if sick even if fully immunized, and cut down on unmasked close contact activities which has been driving ongoing community transmission. Additional mandatory measures, reinstating capacity limits that were recently lifted by the province and strengthened masking and physical distancing requirements.

A class order was issued under section 22 of the Health Protection and Promotion Act requiring any confirmed or suspected individuals with COVID and close contacts to isolate and follow public health direction. Non-compliance is an offence and can be enforced on conviction liable to fines. J. Loo acknowledged the tremendous work and long hours taken on by all members of the APH team as they continue to respond to a very high number of cases.

We are receiving assistance for case contact management from the Provincial Workforce as well as a partner health unit so that we can continue to notify cases in a timely way. We have continued to progress well with immunization with over 90% of eligible residents receiving one dose and 86% with two doses. This brings us to 77% or approximately 88,000 of the total population of Algoma are fully immunized. Health Canada has now approved for 5-11 year olds to receive the Pfizer pediatric vaccine and are now recommended by the national advisory committee on immunization. We anticipate midweek arrival of the vaccine and our earliest clinic at the end of this week is already booked up in Sault Ste. Marie. We also have district clinics that are rapidly being booked up. There will also be additional appointments and walk in opportunities at participating pharmacies as well as primary care providers. In regards to the ongoing surge - our rates have remained very high and even with vaccination rates being high we will be proceeding with additional measures targeting high risk activities in the community where unmasked close contact takes place.

We have been working with school partners to implement additional measures in those settings. Everything is being done in consultation with local stakeholders as well as the provincial office of the Chief Medical Officer of Health. With the arrival of vaccines everyone is that much more protected given our high coverage rates, however there are still those vulnerable and we must preserve health care capacity. We are balancing the commitment to keep schools and businesses safely open with the need to temper some activities. Additional measures will be a targeted approach rather than widespread implementation across municipalities and there is a liaison working with municipalities at the local level for additional measures where warranted.
