How the IPAC Lapse was identified	Public Complaint received on September 30, 2019 regarding improper hand hygiene and glove use and insufficient record keeping.
Summary Description of the IPAC Lapse	The client reported that they were cut during a manicure. Operator did not wear appropriate personal protective equipment (gloves) or wash their hands while attending to the laceration on the client. Operator failed to document the client's name and contact information and details regarding the incident. Improper use and application of surface cleaning / disinfectant agents at the manicure station was also noted during the inspection.
